### 1. Unique identification of the packaging

This declaration covers the following packaging components, which together make up the Chipolo CARD 2-pack packaging. The box includes an integrated die-cut insert assembly (woodfree paper and grey board layers) that holds both cards in place; this insert assembly does not have its own SKU and is supplied as part of the box configuration:

### 3. Sole responsibility

This declaration of conformity is issued under the sole responsibility of the manufacturer.

### 4. Object of the declaration

Single-use, non-food-contact sales packaging for two Chipolo CARD tracking cards, 2-pack configuration. The packaging is a printed paperboard box (SKU MPR.0000165.000) with a die-cut hang tab and a die-cut insert assembly that holds both cards in place, together with a printed paper sleeve (SKU MPR.0000167.000). The box, sleeve, hang tab, and paper insert layers are made from woodfree paper, supplied by Baosong Paper (China). The insert assembly also includes one 2 mm grey board divider layer separating the two card cavities. The only surface treatment is an oil-based overprint varnish on the printed graphics; there is no plastic lamination, film coating or composite layer.

This declaration covers the single standard color variant of this packaging (Charcoal).

Flat sleeve blank dimensions: approximately 326 mm x 170 mm. Assembled/folded package footprint is approximately 140 mm x 139 mm x 16 mm.

The quick-start guide, user manual, handling & warranty leaflet and regulatory compliance leaflet packed inside the box are product documentation and are excluded from the packaging composition assessed here.

## 5. Relevant Union harmonisation legislation

The object of this declaration is in conformity with the requirements under Regulation (EU) 2025/40 of the European Parliament and of the Council of 19 December 2024 on packaging and packaging waste (OJ L, 2025/40, 22 January 2025), including the transitional essential requirement retained by Article 70 from Directive 94/62/EC.

## 6. Standards, common specifications and technical specifications

With the exception of the transitional essential requirements for packaging minimisation under Article 70(1)(b), no harmonised standards under Article 36 or common specifications under Article 37 of Regulation (EU) 2025/40 are currently available.

To demonstrate and verify conformity, the following harmonised standards (applied as transitional provisions or guidance) and analytical test methodologies were applied:

- Heavy metals concentration limits (Article 5(4)): quantified by ICP-OES/AAS and UV-Vis analysis, in accordance with the accredited laboratory test reports covering the paper and ink components of this packaging.
- Recyclability (Article 6(1)): EN 13430:2004.
- Packaging minimisation (Article 10 / transitional requirement under Article 70(1)(b)): EN 13428:2004.

## 7. Notified body

Not applicable. The PPWR Annex VII internal production control procedure used for this packaging does not require notified-body intervention.

## 8. Additional information

The technical documentation required to demonstrate conformity is compiled and maintained in the technical file under reference TF-Chipolo-CARD-2pack, Version 1.0, dated 07.08.2026.

This declaration applies only while series production remains identical to the assessed configuration for the listed Charcoal color variant.
