1. Unique identification of the packaging

This declaration covers the following packaging component, which makes up the Chipolo POP bulk transport carton:

3. Sole responsibility

This declaration of conformity is issued under the sole responsibility of the manufacturer.

4. Object of the declaration

Non-food-contact tertiary (transport) packaging used to consolidate multiple Chipolo POP units for shipping. The carton (SKU MPR.0000104.001) is a double-wall corrugated board box, supplied by KARTEM d.o.o. External dimensions are approximately 530 mm x 342 mm x 202 mm, with a stated carton weight of approximately 730 g. The bill of materials for this carton also includes a secondary, lighter single-wall board component.

5. Relevant Union harmonisation legislation

The object of this declaration is in conformity with the requirements under Regulation (EU) 2025/40 of the European Parliament and of the Council of 19 December 2024 on packaging

and packaging waste (OJ L, 2025/40, 22 January 2025), including the transitional essential requirement retained by Article 70 from Directive 94/62/EC.

6. Standards, common specifications and technical specifications

With the exception of the transitional essential requirements for packaging minimisation under Article 70(1)(b), no harmonised standards under Article 36 or common specifications under Article 37 of Regulation (EU) 2025/40 are currently available.

To demonstrate and verify conformity, the following harmonised standards (applied as transitional provisions or guidance) and analytical test methodologies were applied:

- Heavy metals concentration limits (Article 5(4)), recyclability (Article 6(1)), and packaging minimisation (Article 10 / transitional requirement under Article 70(1)(b)): conformity is supported by the KARTEM d.o.o. declaration of compliance dated 24 March 2026, covering the corrugated board used in this carton, including REACH, PFAS, RoHS and heavy-metal substance restrictions and EN 13427 through EN 13432 assessments.

7. Notified body

Not applicable. The PPWR Annex VII internal production control procedure used for this packaging does not require notified-body intervention.

8. Additional information

The technical documentation required to demonstrate conformity is compiled and maintained in the technical file under reference TF-Chipolo-POP-Bulk, Version 1.0, dated 07.08.2026.

This declaration applies only while series production remains identical to the assessed configuration for the listed transport carton configuration.
